Accelerated Arbitration Course for Advocates and Attorneys ¹

Overview

This course is designed specifically for practicing Advocates and Attorneys who wish to become Fellows of the Association and be eligible for appointment as arbitrators by the Association. The course extends and expands the knowledge and skills that candidates have acquired as a result of their profession. In order to complete this course successfully, candidates should be prepared to devote approximately sixteen hours per week per module to their studies. Successful completion of the Association's accredited courses will entitle candidates to apply for CI Arb membership, as more fully set out in Footnote 1 below.

Learning Format / Course Structure

The course consists of the Law and Practice of Arbitration, International Arbitration and Evidence, and Award Writing. Any person wanting to undertake the course may make application by completing the enrollment forms. The link to this facility can be found on the Association's web page, www.arbitrators.co.za.

The Association's courses are presented exclusively through e-learning. However, students are expected to attend three compulsory workshops for this course, which are held in Johannesburg.

Students will therefore be required to have access to the Internet in order to be able to download the course material, submit the compulsory assignments and receive communications from the Association.

Requirements for Enrolment

The prospective student must be or become a Member of the Association and, in addition thereto, he/she must be a practising Advocate or Attorney for at least five uninterrupted years and have appropriate alternative dispute resolution experience.

Certificate Course in Arbitration¹

Overview

The course has been specifically structured to provide a general introduction to the principles of law and arbitration. The courses are intended for all those who consider arbitration as a positive alternative procedure for settling disputes; including advocates, attorneys as well as those with no formal law qualifications such as accountants, project managers, members of the construction industry, and all business where a dispute may arise. Successful completion of the Association's accredited courses will entitle candidates to apply for CI Arb Membership as more fully set out in Footnote 1 below.

Learning Format / Course Structure

The course consists of two modules (Modules 1 and 2). Potential Candidates may enroll to undertake either one or both modules to run concurrently. Any person wanting to undertake the course may make application via the E-Learning Portal. The link to this facility can be found on the Association's web page, www.arbitrators.co.za.

The Association's courses are presented exclusively through e-learning. However, students are expected to attend two compulsory workshops for this course which are held in Johannesburg.

Fellowship Admission Course¹

Overview

This course is designed specifically for those who wish to practise as arbitrators as well as for those who wish to qualify for Fellow status of the Association and for appointment by the Association as arbitrators. The course extends and expands the knowledge and skills that candidates have previously acquired. This course will make considerable demands on the candidates' time. In order to complete this course successfully, candidates should be prepared to devote approximately seven hours per week per module to their studies. Successful completion of the Association's accredited courses will entitle candidates to apply for CI Arb Membership as set out more fully in Footnote 1 below.

Learning Format / Course Structure

The course consists of two modules (Modules 3 and 4). Module 4 may only be undertaken concurrently with or after completion of Module 3. Neither module may be undertaken until Modules 1 and 2 (Certificate Course in Arbitration) have been completed. The Association's courses will be presented exclusively through e-learning. Any person wanting to undertake the course may make application by completing the enrollment forms. The link to this facility can be found on the Association's web page, www.arbitrators.co.za.

The Association's courses are presented exclusively through e-learning. However, students are expected to attend two compulsory workshops for Module 3 and one compulsory workshop for Module 4 which will be held in Johannesburg.

Students will therefore be required to have access to the Internet in order to be able to download the course material, submit assignments and receive communications from the Association.

The prospective student must be a Member of the Association, who has completed the Certificate Course in Arbitration (Modules 1 and 2) or who has been exempted from Modules 1 and 3 through holding a South African LLB.

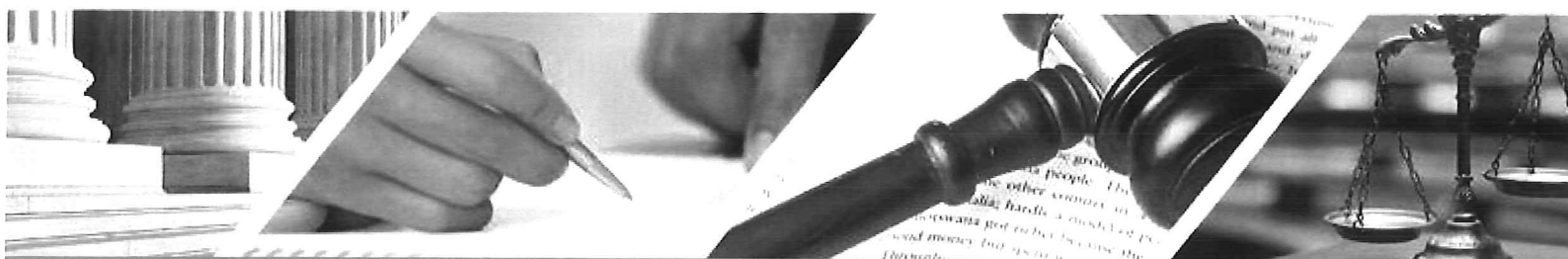

Specialisation in Construction Law Course (with Enrolment Exemptions)

Overview

This one year course (introduced for the first time in 1998) focusses on the advanced law of contract, peculiar to the engineering profession and construction industry, with special emphasis on the common law applicable thereto. Applicable case law is addressed and candidates are furnished with course notes on the relevant principles. Successful candidates will be awarded a Certificate of Specialisation in Construction Law.

Learning Format / Course Structure

The course consists of one module (Module 5). Any person wanting to undertake the course may make application via the E-Learning Portal. The link to this facility can be found on the Association's web page, www.arbitrators.co.za.

The Association's courses are presented exclusively through e-learning. However, students are expected to attend one compulsory workshop for this course which is held in Johannesburg.
